Re: Vaccinating Community PCPs to Address Infection Surge

Dear Governor DeSantis:

On behalf of the 6,200 family physicians, family medicine residents, and medical students comprising the Florida Academy of Family Physicians (FAFP), thank you for your ongoing responsiveness and assistance with addressing the COVID-19 crisis. Your agencies and associated teams and task forces continue to effectively respond to the pandemic and work to support the citizens of Florida as best as possible. With every Floridian's best interest in mind, the FAFP requests that special consideration be given to Florida's community based primary care physicians for receiving the COVID-19 vaccine during Phase I of Florida's Vaccination Plan.

As we know from previous experience in March and April of this year across the country, it is critical that hospitals and associated health systems throughout Florida prepare to best respond to the expected COVID-19 related surge of at-risk individuals who will be inevitably admitted for treatment after the holidays. We also recognize the need to prioritize COVID-19 vaccine administration to at-risk populations and those front-line, first responder physicians and healthcare personnel at the highest risk of exposure in these institutions. Consequently, it is critically important to not ignore the need to limit this surge by ensuring non-critical, COVID-19 positive patients have a trusted, reliable alternative other than the hospital emergency departments.

The FAFP recommends a logical solution is to vaccinate community based primary care physicians who are unaffiliated with hospitals during phase I and that patients be strongly encouraged to seek care accordingly, via physician practices and urgent care clinics, prior to going directly to the ER. Maintaining a healthy primary care workforce can be a gamechanger once the inevitable increase in cases and associated illnesses begin in late December and early January. Florida's family physicians stand ready to assist you and emergency response departments/agencies as the COVID-19 vaccination plan continues to unfold.

Re: Vaccinating Community PCPs to Address Infection Surge

Dear Dr. Rivkees:

On behalf of the 6,200 family physicians, family medicine residents, and medical students comprising the Florida Academy of Family Physicians (FAFP), we appreciate you and the Florida Department of Health's (DOH) ongoing responsiveness and assistance with addressing the COVID-19 crisis. It is nothing short of a herculean effort to effectively coordinate response between DOH in Tallahassee, your county health departments, local hospitals and health systems, and more to keep all Floridians healthy and safe during this ongoing crisis. With this in mind and similar to our letter to Governor DeSantis, the FAFP requests that special consideration be given to ensure Florida's community based primary care physicians receive the COVID-19 vaccine during Phase I of Florida's Vaccination Plan.

As we know from previous experience in March and April of this year across the country, it is critical that hospitals and associated health systems throughout Florida prepare to best respond to the expected COVID-19 related surge of at-risk individuals who will be inevitably admitted for treatment after the holidays. We also recognize the need to prioritize COVID-19 vaccine administration to at-risk populations and those front-line, first responder physicians and healthcare personnel at the highest risk of exposure in these institutions. Consequently, it is critically important to not ignore the need to limit this surge by ensuring non-critical, COVID-19 positive patients have a trusted, reliable alternative other than the hospital emergency departments.

Based upon recent discussions, the FAFP understands that the five hospitals receiving the initial 120,000 COVID-19 vaccine doses are encouraged to consider community physician outreach in order to coordinate vaccinations when sufficient supplies exist. However, we strongly recommend, based upon the examples provided above, that a higher priority be placed on vaccinating community based primary care physicians who are unaffiliated with hospitals during Phase I. Furthermore, that patients be strongly encouraged to seek care accordingly, via physician practices and urgent care clinics, prior to going directly to the ER. Again, maintaining a healthy primary care workforce can be a gamechanger once the inevitable increase in cases and associated illnesses begin in late December and early January. Florida's family physicians stand ready to assist you and your emergency response departments/teams as the COVID-19 vaccination plan continues to unfold.
